First Team All Ohio Basketball - Ja'Kyevion Roane

Ms. Romano, Co-Athletic Director and Mr. Beasley, High School Principal presented Ja'Kyevion with the Outstanding Tyger award for his many accomplishments in Basketball over the last 4 years including being selected for First Team All Ohio, Ohio Cardinal Conference POY, First Team District 6, First team OPSMA Northwest District, 1,000 point scorer (1,198), North Central Ohio POV, Mansfield News Journal POY, Daprise Owens Most Outstanding Player this year, and Mansfield News Journal All-Star Player. Matt Domka. The students were honored for achieving Superior ratings at this Spring's OMEA Solo Contest. Mr. Domka also stated that all three students are also members of the Mansfield Youth Symphony. Mr. Domka thanked Ms. Lindsay for her work with all of the younger students at Malabar. Having this feeder program along with private lessons and being members of the Youth Symphony has helped these students become the accomplished musicians they are and he looks forward to working with them in the next few years.

<u>Mansfield Sr. High Football Coach</u> – Jack Soliday, Co-Athletic Director introduced our new Football Coach, Antonio Fletcher. HB 36 – Proposed HB 96 – General Fund Carryover Gap – Todd Martin, Deputy Superintendent NCOESC

Todd Martin, Deputy Superintendent of the North Central Ohio Educational Service Center, delivered a presentation on the potential consequences of House Bill 96, emphasizing the serious and potentially catastrophic impact it could have on public schools. He noted that the bill is now moving to the Senate for further consideration and possible revisions.

Mr. Martin stressed the importance of reaching out to our state senators immediately to express concerns about how the following provisions could severely impact the financial future of Mansfield City Schools:

- 1. A requirement for county budget commissions to reduce property tax rates for residents in districts where the cash balance exceeds 30% of the previous year's general fund expenditures.
- 2. A direct attack on the 20-mill floor, which threatens the foundational funding mechanism for public education.

25 – 78 Resolution to Implement a Reduction in Force Program for the 2025-2026 School Year for Certificated Staff

Mr. Elswick moved and Mrs. Golden seconded a resolution to implement a reduction-in-force program for Certificated staff for the 2025-2026 school year.

WHEREAS, the Superintendent and Treasurer have provided the Board with information regarding the current and projected financial condition of the Mansfield City Schools District,

WHEREAS, the Board has reviewed the financial information provided, and the financial information provided reveals a current and projected deficiency of funding to maintain current levels of staffing and operations,

WHEREAS, the Mansfield School Employees Association (MSEA) was notified on March 5, 2025, of the reasons for an intent to implement a R.I.F., being: decreased enrollment of pupils over a reasonable period of time, and the financial condition of the school district,

WHEREAS, the notification to the MSEA was consistent with the collective bargaining agreement between the Board and the MSEA.

NOW, THEREFORE, the Board determines that it is necessary to reduce the number of certificated positions for reasons of economy, as a result of reorganization for the efficient operation of the school district and due to lack of funds because of the current and projected deficiency of funding to maintain current levels of staffing and operations and the estimated savings with respect to salary and benefits of the positions to be reduced. The Board further approves that the administration take the necessary steps to reorganize positions for the efficient operation of the district.

BE IT FURTHER RESOLVED that the following reductions are approved:

Position of Springmill STEM Teacher, resulting in a reduction of 1 employee.

Position of CTE - Automotive/Construction Agriculture Teacher – Middle School shall be abolished, resulting in the reduction of 1 employee.

Position of 7-8 Social Studies Teacher - Middle School shall be abolished, resulting in the reduction of 1 employee.

Position of 9-12 Science Teacher - Senior High School shall be abolished, resulting in the reduction of 1 employee.

Position of CTE-Business Law Teacher - Senior High School shall be abolished, resulting in the reduction of 1 employee. Position of School Counselor - Springmill STEM/Hedges split, resulting in a reduction of 1 employee.

Position of 9-12 Social Studies Teacher - Senior High School shall be abolished, resulting in the reduction of 1 employee.
