#### Every Student, Every Day Champion

Jonathan Burras, Director of Special Education nominated and introduced this month's Every Student, Every Day Champion, Mrs. Sonja Clever. Mrs. Clever is an Intervention Specialist at Mansfield Senior High School, a registered Behavior Technician and studying to become a BCBA. Mr. Burras praised Mrs. Clever for being an advocate for students and a strong instructional leader, a true champion for her students. Mrs. Clever thanked Mr. Burras and the board for this honor and proceeded to introduce the students she chose to be her champions. Javon Jones is a freshman student who has grown as a leader this year, he works hard to include his peers. Alexis Otterbacher is a student that Mrs. Clever has taught for 2 years. Since her return from TDA, she helps students every day with tasks they are struggling with. Both of these students stand out every day for their ability to lead and their compassion for helping others.

#### Core Management - COVID Third Party Compliance Audit

Mr. Booth, our Facilities Manager introduced members of the Core Management Team who performed a Custodial Assessment of our district this past fall. They collected information, measured cleanable square footage, calculated staffing workloads and conducted a Quality Audit, and did site visits. On the whole, the audit was quite favorable for our buildings and custodial staff. Areas that needed attention were identified and the district will continue to work with Core Management to improve the cleanliness and safety of our buildings as we return to full time in-person learning.

#### Dr. Arianna Howard - Cultivating a Climate of Equity and Cultural Competency

Mr. Jefferson introduced Dr. Arianna Howard. Dr. Howard is a master trainer and leading cultural diversity expert. She possesses extensive educational experience and has effectively facilitated radical work with school leaders, resulting in equitable teaching and learning environments. Dr. Howard is President and CEO of Plan-A-Seed Educational Consulting. Dr. Howard lead the board in a self-reflective exercise as an example of some of the work she is performing in our staff trainings and workshops. She shared survey results that she has gathered after her 2 rounds of trainings and has experienced positive feedback. She will be presenting additional trainings and workshops in Professional Development for Prospect, Malabar, the Middle School and High School this Spring.
