### Presentations:

#### Children's Hunger Alliance Award

Ms. Lauren Moran the district's Food Service Manager shared with the board that our district was recently recognized As the Children's Hunger Alliance Weekend Meal Program of the Year at the CHA Menu of Hope Event. Ms. Moran shared a video that CHA produced at Sherman Elementary, featuring the weekend meals distribution, along with teacher's and student's appreciation for the program. Ms. Moran shared that we hope to expand this valuable program to Woodland Elementary students soon.

#### Youth & Government

Mr. Robert Watson, Sr. High Government teacher addressed the board and introduced a group of high school students who are members of the Ohio YMCA Youth & Government and asked the board for permission to attend their yearly conference in Columbus this month. This experience will teach the students to use the legal system to make change. Students will visit the State House and actually work as Legislators. This experience will open up student's views, add opportunities for them and allow them to make friendships with others attending from around the state.

#### Winter Sports Review

Kevin Porter, MCS Athletic Director recognized our winter sports teams and athletes and their many accomplishments. Our diving team had two state qualifiers, Macey Wade and Nash Nicholson. In Wrestling, Mekhi Bradley and Leo Hess were both 4<sup>th</sup> place State winners in their weight class.

#### Campus Wear/Dress Code

Mr. Stephen Rizzo, Chief Academic officer gave a detailed presentation regarding Campus Wear and the Dress Code in Mansfield City Schools. Mr. Rizzo along with Mr. Cunningham, a teacher at MSHS, reviewed the challenges and concerns with Campus Wear in grades 7-12, gave evidence of their findings, and research gathered to support the development of the five recommendations presented. A steering committee from MSHS and MMS proposed implementing a Dress Code for grades 7-12 that aligns with the dress code currently in place for grades PreK-6 students. Several students and a few teachers and parents spoke during the public participation, supporting the proposal to replace the current campus wear policy and pilot the proposed Dress Code for the remainder of the 22-23 school year. Mr. McQuate, principal at MSHS, spoke prior to the presentation in support of the work to date, including the recommendations. The resolution was tabled. The board asked the Superintendent to form a larger stakeholder committee to address student dress for grades 7-12 for the 2023-2024 school year.
