Presentations:

Every Student, Every Day Champion – Allison Weeks, Secretary, Prospect Elementary

Mr. Jefferson asked Mr. Rizzo to present our Every Student, Every Day Champion for this month. Mr. Rizzo said that occasionally the person that nominates a Champion asks to remain anonymous. However, this evening Ms. Taryn Nall, our counselor at Prospect Elementary said that she would be more than happy to nominate and recognize Mrs. Allison Weeks and she is here this evening to do so. Ms. Nall stated " I work with Allison, who is our secretary at Prospect and she does an excellent job with students, staff, and families. The staff loves her and she handles challenges with grace and expertise. I've watched her grow in her job over the past few years and feel that she is an asset not just to Prospect but to the Mansfield City School District as a whole. Not only did you hire an excellent employee, I also have a new friend. " Many of the Prospect staff were in attendance and applauded Ms. Nall's nomination and recognition of Mrs. Weeks.

Samuel Kime – Mansfield Sr. High – Associates Degree

Mr. Rizzo stated that he would be recognizing Samuel Kime this evening. Sam recently received his Associates Degree from The Ohio State University. Mr. Rizzo read part of a letter of recommendation from Sr. Principal Kris Beasley for Sam's OSU Alumni scholarship application. In part; "Sam has been enrolled in accelerated programs from his 1st days at Mansfield Senior and even going back to 7th grade. While being a student here at Mansfield Senior High School Sam has shown laser-like focus on his academics taking all of the advanced courses we could enroll him in as well as taking CCP coursework beginning as a freshman and an entire CCP schedule for his 11th and 12th grade years. Sam's determination and academic excellence has led to him graduating from High School with an Associate's Degree in the first semester of his senior year. Mr. Rizzo stated, on behalf of Mr. Beasley, the students of the class of 2022 as well as the administration, we congratulate you in all that you have accomplished.

William Payne – Student Athlete

Kevin Porter, MCS Athletic Director welcomed the opportunity to recognize William Payne, he said that William epitomizes the term student-athlete. Mr. Porter proceeded to read from a list of William's accomplishments. Sam will also graduate with an Associate's degree from OSU and has interest from a few schools to continue his diving career. Will plans to pursue a degree in Engineering (Structural or Mechanical) and his dream school is Stanford. Will started diving during his Sophomore year and finished 7th at OCC meet and 21 at districts (108.7) .In his junior year he finished 4th at OCC and 10th at Districts (331.4) and 21st at State (128.1).He was OCC champ with a total dive of 469.50 (11 dives) which broke a 41 year old record and was named Diver of the Year, He finished 3rd at Districts (383.3). Board Matters

Public Participation: Sherry Reese-Vaught, Prospect Teacher, city school resident and parent of a Mansfield City School graduate. Ms. Vaught assured the board that she was aware that the district needed to close a building to reach capacity. Her concern, as well as others was that the first proposal was met with resistance from Spanish Immersion parents and staff with concerns that if the Spanish Immersion program was moved, there would not be room for their specials or middle school classes. After their input and the consideration of other issues that arose, Prospect was selected for closing with a one day notice to staff and families.

Board Comments:

Mr. Feagin said that it has been a tough 2 months for all and that they knew whatever the decision was made, there would be a group that would not be happy with their choice. However, there was a lot of thought put into their decisions and reconsiderations took place when new or additional information was shared.

Mrs. Weber agreed with Mr. Feagin. She also stated that she knew firsthand how tough it is when a building is closed. She also lives in the Prospect district and her daughter attended that school so it feels personal and it will affect her neighborhood, but it is what is best for the students and the district at this time as we try to move forward.

Ms. Cline said that equity has always been of the highest importance for her. Closing a building is not easy, there has been a lot of thought and talk put into this decision, and at this time it is what needs to be done and what is best for all of the children of the district for this coming school year.

Mr. Elswick said that this building closure plan did start years ago before the pandemic. And at that time Prospect was slated to close. Mr. Elswick stated that he is not happy with the process and how things were handled, but after talking with Mr. Booth who is on the Facilities Committee with him, the savings is more than it was originally stated, costs were reexamined and at the end of the day, we're doing what's best for the community and everybody.
